

**REGULAR MEETING  
MARCH 2, 2009**

The City Council of the City of Forest City, Iowa, met in regular session on March 2, 2009, at 7:00 p.m. in the Council Chambers of City Hall, Forest City, Iowa.

Mayor George Wilson called the meeting to order. Councilmembers present at roll call were: Sorensen, Caputo, Clouse, Holland, Murphy, Skjeie. Absent: West.

Mayor Wilson announced that this is the time and place for a public hearing regarding the fiscal year-end 2010 Budget for the City of Forest City, Iowa. City Clerk Paul Boock reviewed the Budget Notice that was published in the Forest City Summit. Since there were no written objections filed nor were there any oral objectors present at the meeting, the Mayor declared the hearing to be closed. The Council took the following action:

Councilmember Sorensen introduced the following resolution and moved its adoption. Councilmember Murphy seconded the motion to adopt. The roll was called and the vote was: AYES: Sorensen, Caputo, Clouse, Holland, Murphy, Skjeie. NAYES: None. ABSENT: West. Whereupon the Mayor declared the resolution duly adopted as follows:

Resolution No. 08-09-26, a Resolution found in Resolution Book 08-09. A RESOLUTION APPROVING THE FISCAL YEAR-END 2010 BUDGET FOR THE CITY OF FOREST CITY IN WORDS AND FIGURES AS PUBLISHED IN THE BUDGET HEARING NOTICE DATED FEBRUARY 18, 2009.

Moved by Holland, seconded by Skjeie, approving the minutes as written for the meeting of February 16, 2009. Motion carried unanimously.

Moved by Holland, seconded by Sorensen, approving payment of the following invoices. A list of the invoices will follow the minutes of the meeting. Motion carried unanimously.

The Mayor reported that the Planning and Zoning Commission recommended naming the alley abutting Titonka Savings Bank be called TSB Way. After discussion, the council took the following action:

Councilmember Murphy introduced the following resolution and moved its adoption. Councilmember Skjeie seconded the motion to adopt. The roll was called and the vote was: AYES: Sorensen, Caputo, Clouse, Holland, Murphy, Skjeie. NAYES: None. ABSENT: West. Whereupon the Mayor declared the resolution duly adopted as follows:

Resolution No. 08-09-27, a Resolution found in Resolution Book 08-09. A RESOLUTION APPROVING THE NAME FOR THE ALLEY EAST OF TITONKA SAVINGS BANK TO BE TSB WAY IN THE CITY OF FOREST CITY, IOWA.

Moved by Holland, seconded by Sorensen, approving the receipt and disbursement of Back 9 donations in the amount of \$1,000. Motion carried unanimously.

Police Chief Dan Davis reviewed a new ordinance to be considered that relates to underage drinking of alcohol. After discussion, the council took the following action:

Councilmember Skjeie introduced the following ordinance and moved its adoption. Councilmember Murphy seconded the motion to adopt. The roll was called and the vote was: AYES: Sorensen, Clouse, Holland, Murphy, Skjeie. NAYES: Caputo. ABSENT: West. Whereupon the mayor declared the motion carried.

Ordinance No. 686 was then read by the Clerk after which it was discussed. This represents the first reading of Ordinance No. 686. The second reading of Ordinance No.686 will be read at the March 16, 2009, City Council Meeting. Ordinance No. 686 is an ordinance adding provisions to Chapter 45 in regard to underage consumption of alcohol.

Water/Wastewater Elynn Charlson asked the council to pass a resolution naming WHKS as the engineers for developing plans and specifications for roof replacement for the public library and the wastewater treatment facility. After discussion, the council took the following action:

Councilmember Clouse introduced the following resolution and moved its adoption. Councilmember Holland seconded the motion to adopt. The roll was called and the vote was: AYES: Sorensen, Caputo, Clouse, Holland, Murphy, Skjeie. NAYES: None. ABSENT: West. Whereupon the Mayor declared the resolution duly adopted as follows:

Resolution No. 08-09-28, a Resolution found in Resolution Book 08-09. A RESOLUTION APPROVING THE HIRING OF WHKS AND COMPANY ENGINEERS AND APPROVING THE CONTRACT FOR SAID FIRM ALL IN REGARD TO THE 2009 MEMBRANE ROOF

REPLACEMENT FOR THE WASTEWATER TREATMENT FACILITY AND THE PUBLIC LIBRARY FOR THE CITY OF FOREST CITY, IOWA.

Mayor Wilson asked that it be noted in the minutes that Adam Russell has been hired at the Forest City Light Plant to replace Terry Nolton who is retiring. Adam Russell will be paid \$19.61 per hour.

Police Chief Dan Davis updated the council regarding employment levels at the Forest City Police Department. Davis reported that Andrew Klein will be leaving the City on March 5<sup>th</sup> and there will be joint testing done for replacement of officers with Winnebago County. No action was taken on the report.

Pat Galasso of Grow Forest City gave a presentation regarding the findings of the North Star Research Survey. No action was taken on Galasso's report.
